Dear Mr. San Agustin,

The purpose of this letter is to follow up the email submitted to you on January 24, 2007 and formally request additional information to the December 6, 2006 inspection. The following items were requested in the January e-mail:

1. Approximately how many pounds of waste can be stored in a roll-off container such as those observed adjacent to the consolidation area at the time of the Dec. 6 inspection?
2. Please send the Notice of Approval, Compliance Review, Waste Material Profile along with any other important information for the following containers located in the TSD area at the time of inspection:
  - a. ND 1007-1
  - b. DO 91854-96
  - c. DL 99284-1
3. For the following list of containers please answer the questions below; if the containers are a result of consolidation please refer to subset c and c-i.
  - a. When was the container received?
  - b. Where was the container originally accepted (the consolidation area or the TSD area)?
  - c. If the waste was consolidated into another container, what is the consolidation container's ID, date consolidation began, date consolidation was complete, and where is the consolidation container currently?
    - i. For the different wastes that make up the consolidation container what dates were they received and where were they originally accepted (the consolidation area or the TSD area)?


