Dear Mr. Whittle:

The Department has completed its review of the completion of construction of storage unit and the accompanying as-built drawing and professional engineer certification. This hazardous waste container storage unit, constructed in the LSV Processing and Waste Storage Warehouse, and described in Figure I.D.7 and Section II.B of the permit application dated March 9, 2006 consists of two (2) zones for storage of hazardous waste in containers meeting D.O.T specifications measuring 718 gallons or less. The permitted storage area authorizes container storage of maximum volume of 54,340 gallons of hazardous waste.

Based on the engineering certification and visual inspection conducted on April 25, 2007, the Department concurs that the construction requirements of Specific Condition VIII.1 of Permit 17680-009-HC have been satisfied and hereby authorizes Perma-Fix to begin operation of the storage unit upon receipt of this letter. The Department noted that the construction of this storage unit modified the dimensions of the concrete containment berm. Please provide the Department with the following revised pages from the March 9, 2006 Permit Application within forty-five days receipt of this letter: Attachment I.D., Page 11 and Figure I.D.7 for the containment berm height.
