#### Jack:

I have received and reviewed your compliance submittal in response to the Department's inspection dated 8/16/07, and offer the following comments (by item number on the Exit Interview):

1.a) I recall reviewing your facility's Contingency Plan or SPCC Plan during the inspection, and noting that your facility did have in place most of the requirements of the Contingency Plan (Spill Response procedure, instructions for handling contaminated materials & residues, description of emergency response arrangements [needed update], emergency equipment list and capabilities, etc.). The Fire Protection and Emergency Action Plan in your submittal appears to be only a portion of the full Contingency Plan that is required for your facility, since it doesn't contain some of the items I notated during your inspection. With regard to this, there are portions of the Contingency Plan/SPCC Plan that also require updating with regard to emergency coordinators,

including a section that describes the current and updated emergency response arrangements with local authorities. For the purposes of the compliance inspection, please provide copies of those portions of all the associated Contingency Plan documents that required updating. Please ensure that your permit renewal application clearly includes all the documents that your facility maintains to collectively to meet the Contingency Plan requirement. A blank copy of the Department's compliance evaluation checklist for Used Oil Processor facilities is attached for your reference; it is useful in providing a list of the required elements of the Contingency Plan (either as a single document or a compilation of documents):
