The Department of Environmental Protection (the Department) has reviewed CBI's response dated December 6, 2007 concerning Department comments on the Final Letter of Certification for Closure Completion of the CBI – Fort Lauderdale Facility. Based upon analysis of the activities performed to-date and information presented to the Department, CBI has not been able to demonstrate the source of free product at the site or that two hydraulically disconnected aquifers exist the span of the entire site.

Therefore, as previously required by the Department (letters of August 29, 2007 and November 02, 2007), CBI must install all required monitoring wells to demonstrate the origin of free product and also ascertain the theory that two distinct aquifers exist under the span of the site. The Department once again reiterates the following comments from previous correspondence:

1) As requested by the FDEP letter dated November 02, 2007, CBI can install piezometers at the required locations which intersect the water table but do not go into the clay layer. In addition CBI must also install monitoring wells screened below the clay layer. CBI must gauge the piezometers and wells after installation activities. In effect they would be installing twice the number of required wells but splitting the screened intervals. This would allow for CBI to complete the required work while maintaining the integrity of the "alleged aquiclude" and also afford CBI the opportunity to prove their theory regarding the source of product.

2) CBI should provide detailed lithologic logs (FDEP well completion logs), provide field notification, and photographic evidence identifying and documenting the geology at the site.

Please note that CBI Fort Lauderdale permit will expire on February 12, 2008. If the facility cannot be clean closed before the expiration of this permit, the permittee must renew the permit to obtain a closure Permit by submitting the renewal application, including closure cost estimates and Financial Assurance, for closure of the site. The complete renewal permit application must be submitted to the Department no later than February 12, 2008.
