#### Introduction:

On July 31, 2020, John White, Florida Department of Environmental Protection, conducted a routine compliance evaluation inspection of Tank Wizards to determine the facility's compliance status with used oil transporter requirements. Tank Wizards was represented by Wendall Stroderd, President.

Tank Wizards, located at 7619 Coral Drive, West Melbourne, Florida, was last inspected as a registered used oil transporter on August 31, 2015. Violations identified at that time were failure to document EPA identification numbers of generators, where applicable, and dates of acceptance on used oil acceptance forms. The violations were corrected and no further action was required.

#### **Process Description:**

Tank Wizards is a fuel tank cleaning business operating in the southeastern United States. As of calendar year 2020, the facility has discontinued actively transporting used oil and used oil filters but maintains an active registration as a used oil transporter.

The 2019 used oil and used oil filter annual report was provided on March 2, 2020 and documented the facility managed 27,284 gallons of used oil and 6,950 used oil filters in calendar year 2019. Tank Wizards registration as a used oil transporter is valid until June 30, 2021.

No used oil was stored on-site at the time of this inspection.

#### **Conclusion:**

Tank Wizards was inspected as a registered used oil transporter and was in compliance at the time of this inspection.
