A routine compliance evaluation inspection (CEI) was conducted at Shaw Environmental (Shaw), 1228 Winter Garden Vineland Road, Winter Garden, FL. Shaw is registered with the Department as a transporter of hazardous waste.

Process Description:

Shaw personnel stated that although Shaw retains its transporter registration, as a normal course of business, transportation of hazardous waste is sub-contracted to third-party hazardous waste transporters. Shaw personnel stated that Shaw itself had not transported hazardous waste in approximately four to five years.
