Per your inspection findings of November 20, 2009, at the above location, we'd like to offer you the following. I have enclosed photos to show:

- 1. The two 'used oil' small 'under vehicle' mobile containers have been labeled.
- 2. The drum of used anti-freeze has been labeled.
- 3. The 'used oil' tote has been emptied and taken out of service due to the fact that the measurements of the secondary containment revealed that its capacity is 106 gallons. Photo attached shows secondary containment area with tote gone. We are going to be utilizing drums in the shop area from now on, for used oil containers.
- 4. The materials found in the "pole barn" have been removed and the manifest copies showing transportation out are attached.


