Introduction:

Environmental Management Conservation (EMC) is a used oil transporter/transfer facility, hazardous waste transporter, and a Conditionally Exempt Small Quantity Generator (CESQG) of hazardous waste. EMC has been at this location since 1994 and currently employs 14 people. The facility is approximately 38,000 sq ft and is on public utilities.

Process Description:

EMC transports hazardous waste from the customer's facility directly to PermaFix in Fort Lauderdale. EMC picks up used oil, used oil filters, absorbents, and oily water from customers and brings it to their facility to transfer it into tankers and roll offs for final shipments to the receiving facilities. The used oil goes to either Noble Oil or H & J Asphalt. The absorbents are sent to PermaFix, and the used oil filters are taken to US Foundry. Oily water is taken to Cliff Berry.

EMC stores its used oil in an 8,000 gallon tank in secondary containment and in tanker transports located in the parking area.

EMC has a maintenance shop that generates used oil, used oil filters, and parts washing solvent. The parts washer uses diesel and is emptied approximately once a year in to the used oil generated by the shop.
