GENERAL COMMENTS:

1. The Atlantic Industrial Services, Inc. letter of January 23, 2004 referenced a letter dated October 14, 2003 which has not been received at this office. Please provide a copy of this letter.

- 2. Neither the current submittal nor any previous submittal fulfills the requirement of Part III, Item 16 of the permit. Please submit certified "as built" drawings of the solid waste building for the Department's review.
- 3. Page numbering in the submittal is not consistent. Please select a system and use it consistently throughout the application.
- 4. Please provide a certification by a Professional Engineer for the application as modified by the response to this NOD.

## **SPECIFIC COMMENTS:**

- 1. An original signature is required for the Operator Certification, the Owner Certification and the Land Owner Certification. The documents submitted were unsigned.
- 2. Figure 8 and Page 6 of 23. The State Warning Point numbers are (850) 413-9911 and (800) 320-0519. The State Emergency Response Commission number, (800) 635-7179, is a business hours only number.
- 3. Page 66 of 81, page 67 of 81, page 69 of 81, page (C8) 9-1 of 22, page (C8) 9-2 of 22 and page (C8) 9-4 of 22. Please modify the sketches to show the inside dimensions and use the correct inside dimensions in the calculations.
- 4. Page (C8) 9-3 of 23 uses dimensions that do not agree with Figure 12 as revised on 12/31/03. Please review and revise as appropriate.
- 5. Page (C8) 3 of 22 refers to tanks RN 1- RN 3. Page (C9) 58 refers to tanks RN 1- RN 4. Please review and revise as appropriate.
- 6. On pages 1 of 23 and 6 of 23 in the Spill Contingency Plan, please revise "Florida Department of Environmental Regulation" to "Florida Department of Environmental Protection."
- 7. USGS Map and Warehouse Building Detail are both labeled Figure 1. Site Plan and Evacuation Plan are both labeled Figure 2. Please provide a unique number for each figure.

- 8. Figure 5 shows used oil tanks that are not included elsewhere in the application. Some of the numbers identifying these tanks duplicate the numbers of other tanks at the facility. Please review and revise as appropriate.
- 9. Figures 6 and 13 show a North arrow that is not consistent with the North arrow on Figures 2, 3, 4 etcetera. Please review and revise the North arrow orientation on all layout figures as appropriate.
- 10. Figure 6 does not appear to match the other figures as to the number, location and capacity of the tanks. None of the figures match the permit. Please review the figures and revise as appropriate.
- 11. Please modify an existing figure or provide an additional figure that shows all the names and numbers that are used to designate each tank and each secondary containment area.
