Also, the latest version of the language I proposed to send to Robin is attached. This is based on Bryan's e-mail of 3/3/04 4:05 pm:

I believe we were referring to a 10x factor for the gw protection level, not a straight 10ppb. That would make the amino-dinitrotoluenes 4ppb and 2,4-DNT 0.6ppb. From what I've been able to find out, DNT should be relatively stable once it hits groundwater. It does not hydrolyze. So, only dilution/dispersion will reduce the concentrations. And the concentrations for both hovered very near the normal protection limits.
