2. LOCATION OF VIOLATION:

10100 Rocket Blvd, Orlando Florida 32824

3. NATURE OF VIOLATION:

Hazardous Waste Treatment, Storage and Disposal (TSD) Facility (10100 Rocket Blvd): On January 25, 2010 Janine Kraemer, Michael Eckoff and Kim Rush, FDEP, Robert Burns, Department of Transportation (DOT), accompanied by Cory Howard, Perma-Fix of Orlando (Perma-Fix), inspected Perma-Fix for compliance with hazardous waste, solid waste, used oil and federal transportation rules and regulations. The facility is a hazardous waste and used oil transporter, 10-day transfer facility, a permitted used oil processor, and permitted storage facility of solid and hazardous waste. See attached inspection report and revised penalty calculations for specific violations (Exhibit I).

4. <u>PENALTY RATIONALE</u>:

In accordance with the FDEP and USEPA penalty guidelines, the civil penalty of \$24,354.00 is being sought against Perma-Fix.

In lieu of making a cash payment of \$24,354.00 in civil penalties, Respondent has elected and the Central District is recommending approval for the Respondent to off-set up to \$21,919.00 of this amount (that is, up to 90% of the civil penalty amount) by implementing a supplemental environmental project ("SEP"). The value of the SEP shall be one and a half times the civil penalty off-set amount, which in this case is the equivalent of at least \$32,878.00.

For the SEP, Respondent will provide advertising, lab packing services, packaging, and tent, for excess, unused, deteriorated or out-of-date pharmaceuticals from home owners. The event will coincide with the national event on November 13, 2010, Operation Medicine Cabinet. The Respondent will be required to supply an itemized report of the cost, and type and number of advertising spots for the Consent Order. Perma-Fix has agreed to supply the costs by July 30, 2010.

Respondent shall complete the entire SEP on November 13, 2010. The notification of completion shall include documentation of all cost and claimed credits not previously approved by the Department. This document will be due no later than November 30, 2010.
