The purpose of this letter is to provide notice that your Operating Permit 34744-HO-005 will expire on November 23, 2011. Prior to one hundred-eighty (180) calendar days before the expiration of the permit, a complete application for the renewal of the permit must be submitted on forms and in a manner prescribed by the Department and as required in your permit. A complete application is due by May 27, 2011.

One hard and one electronic copy of the permit application shall be sent to:

The renewal fee may also be submitted electronically. However, if the Permittee intends to submit the renewal fee electronically, the Permittee must obtain instructions from the Department on how to submit the renewal fee electronically prior to attempting such submittal, and must follow such instructions in making the electronic fee submittal.
