Your Contingency Plan (CP), Revision 15, was reviewed by Jacksonville and Tallahassee staff and it is acceptable. Submittal of your CP meets condition Part 1 27f. of your Operating Permit that requires the Permittee to perform, at a minimum, an annual review of the Contingency Plan to ensure that it is up to date and contains current information

The Department does recommend the following:

- ✚ A copy of the CP should be kept off site at an easily accessible and nearby location in the event that emergencies prohibit onsite entry to obtain the CP.
- ✚ You should submit electronic copies (and future updates) of the CP to the state and local authorities listed in condition Part 1.d of your permit.
- ✚ Update your point of contact with the Department to remove Harold Register and replace with Merlin Russell.
