Facility Annual Compliance Inspection was performed on 1/11/11 by Jodie Bell, accompanied by Steve Berman, facility representative. Release Detection is Monthly Visual Inspections of the 2-5800 gallon Waste oil ASTs, (AST's #700 & 701) including the secondary containment area, and all aboveground piping. Records Reviewed: Registration Placard is current and posted, 5/28/10-6/30/11, 2 regulated tanks, 10 other nonregulated Hazardous Substance tanks; all facility info is correct. Financial Responsibility demonstrated, Steadfast Ins. Co. Certificate of Liability; 11/01/10-11/01/11; all tank info is correct. CFR and RDRL are correct , with records. Monthly Visual Inspections reviewed from 1/4/10 to 12/06/10, all dates are OK, system is checked weekly and recorded monthly; all components are covered; minor conditions and repairs were noted; two years records were available. Physical Inspection: AST #700 & 701 are both 5800 gallon SW painted steel vertical waste oil base tanks on concrete pedestals in a sealed concrete secondary containment. Tanks are in good condition, no corrosion, leaks or staining observed. Tanks are labeled, vented, grounded, and have site tube level gauges on the sides. The containment area appeared in good condition, dry and clean; does not have a drain valve, and no roof; water is pumped out as needed. Piping is all aboveground SW 3" galvanized and painted steel. No corrosion, leaks or staining. The supply and fill line are one and the same, exits bottom of tanks, has isolation valves installed, a remote tight fill port, and is all within the containment area; no anti-siphon valve required. Facility is very clean. No photo was taken. Compliance Cover Letter as mailed to facility is attached.
