Dear Mr. Schoepke:

The Remedial Action Status Report referenced above is acceptable.

You notified us on June 10 of the sampling scheduled for June 21. It would be good to include the date of notification in future reports to memorialize this activity for permit compliance purposes. The subject report was received August 5, 2011, within the 180 days after permit issuance (the modification was issued February 9, 2011).

Section 5.3 of the RAP indicates submittal of the as-builts 120 days after initiating operation of active remediation. Active remediation began June 28, 2011. As-builts are due no later than October 26, 2011. Estimated time of completion is approximately December 28, 2012 (547 days).

The second and third quarterly sampling events must occur in September and December 2011. The report for these two events is due no later than February 29, 2012.

As previously mentioned in my September 2, 2010 comments only *one* hard copy of the Remedial Action Status Report (RASR) is needed.
