Dear Mr. Curtis:

Your August 5, 2011 revisions to your application for a hazardous waste permit have been reviewed and found to be substantially complete. There are a few remaining issues, most of which were discussed or resolved with you on Friday, October 7.

A contingency was not included in your cost estimates. Simply resubmit an update that includes a 15% contingency (NOD Comment 33).

It came to our attention during a recent inspection that there is a septic tank and drainfield on the property. These are considered Solid Waste Management Units (SWMUs). In our discussion on October 7, you told me that you were already in the process of completing the information required by Parts P and Q of the permit application for these units. As agreed upon, this SWMU will be considered SWMU-21. You also indicated that a tagging figure for Subpart BB requirements was being drafted and will be submitted.

A couple of pages were missing from the hard copy. Please submit the revised pages:

- Comment 14: A copy of the revised page (regarding management of used oil) was missing from your response.
- **↓** Comment 18.12: A copy of the revised page (regarding waste generated from cleaning the wet dumpsters) was missing from your response.

Although we have no objection to your proposed 24-hour timeframe for loading/unloading trucks and vehicles, you may want to re-evaluate the timeframe. In

order to accommodate holidays and weekends, we have no objection to allowing up to 72 hours, similar to what we have allowed for other facilities (NOD Comment 18.9).

There have been recent occurrences of Safety Kleen accepting wastes that have been mis-profiled. At a minimum, Safety Kleen's sales personnel and chemists must receive adequate training to ensure that they are qualified to ensure that waste profiles are accurate and complete (NOD Comment 19.3).

Note that the federal laws do apply to Safety Kleen although they do not appear to be applicable at this time (Comment 20).

We suggest that page 94 (or elsewhere) be updated and include the statement that Safety Kleen has a policy in place that all spills greater than one cup are reported within an internal database (Comment 30).

For planning purposes, I have already started drafting your renewal permit. I intend to send you a courtesy copy of the draft permit for your review and comments in November. The Intent to Issue is scheduled no later than December 18, 2011.
