Dear Mr. Curtis:

We approve your Confirmatory Sampling (CS) Plan pending a few comments.

After the septic tank is opened, ensure you document the construction details for use in completing Parts P and Q of the permit application (see more discussions below). Ensure you obtain tank dimensions, construction material, locations of pipes that enter and exit the tank, determine if the tank is chambered, etc.

For sampling the tank contents, be prepared to take more than one sample. If multiple phases are present, samples from each phase must be collected.

As we discussed on October 8th, ensure that you submit the information required by Parts P and Q of the permit application with your CS Report. I would suggest enclosing photographs of the tank. Historical information must also include any maintenance, specifically, information documenting septic tank cleanouts, any sampling of contents, and management of the waste.

Although you have already complied with the notification of field activities, please contact Jim Dregne on Tuesday (November 15, 2011) after the temporary well is installed. The Department may wish to observe the sampling on Wednesday.
