The purpose of this letter is to provide notice that the Boynton Beach Operating Permit No. 49625-HO-005 will expire on November 19, 2012 and the Medley Operating Permit No. 56019/HO/006 will expire on March 19, 2013. Prior to one hundred-eighty (180) calendar days before the expiration of the permit, a complete application for the renewal of the permit must be submitted on forms and in a manner prescribed by the Department and as required in your permit. Complete applications for Boynton Beach and Medley are due by May 23, 2012 and September 20, 2012, respectively.

One hard and one electronic copy of the permit application shall be sent to:

The application shall meet the fee requirements of Rule 62-730.293, F.A.C. The fee should be submitted along with the application to the address above.

The renewal fee may also be submitted electronically. However, if the Permittee intends to submit the renewal fee electronically, the Permittee must obtain instructions from the Department on how to submit the renewal fee electronically prior to attempting such submittal, and must follow such instructions in making the electronic fee submittal.

Because the permit applications are due this year, we strongly suggest scheduling a preapplication meeting or teleconference as soon as possible. To assist in you in submitting a complete and adequate Part B of your application, the following suggestions are offered:

If you are *not* intending to submit an entire, stand-alone Part B, and simply plan to assert that there are no changes in the application (as allowed by paragraph 62-730.291(2)(b), F.A.C.) then we ask that your cover letter specifically cite the name and date of the Part B you are renewing. In turn, that Part B will be reviewed in its entirety to ensure that it is current. Keep in mind that the Contingency Plan, Preparedness and Prevention Plan, Waste Analysis Plan, Training, Recordkeeping, etc., all part of your Part B, must be complete and current. Our recommendation is to submit an updated, stand-alone Part B. Because we are currently renewing the permit at your Tampa facility, identical or similar information from the Tampa renewal relevant to your Boynton Beach and Medley facilities should be included in their renewals.

If you have new or previously unreported Solid Waste Management Units (SWMUs), make sure you provide the information required in Parts P & Q of the application. If reports (e.g., SARs) on these SWMUs have been previously submitted to us, you can simply reference those reports in Parts P & Q. Please ensure all SWMUs are on your list. Many facilities do not include <90-day accumulation areas, satellite accumulation areas, septic tanks and drainfields, used oil facilities, mercury-containing device management areas, etc. Although these examples are not RCRA-permitted units, they do meet the definition of SWMUs.
