Dear Mr. Schoepke:

The second paragraph of the PARM references a supporting document that is currently in preparation, so at this time I was unable to confirm the statements in this first paragraph. That document will be reviewed separately once it is received. For the purpose of this letter, I am only reviewing the proposed groundwater monitoring, and will confirm later that the submittal of the PARM is supported. With this qualification, the *Post Active Remediation Monitoring Plan* submitted on your behalf by ECT is conditionally approved.

Note that the PARM does not explicitly discuss the resampling that may be required by subsection 62-780.750(4)(e), F.A.C., if concentrations of applicable contaminants exceed any of the Groundwater Cleanup Target Levels (GCTLs). This subsection requires resampling within 30 days after the result is received. From a practical point, the proposed 6-week sampling interval will essentially serve this purpose (considering the time required for lab analysis, reporting and 30-days to resample). Also, in support of the subsection's intent, the PARM does require that any well detecting a constituent above its GCTL be sampled in subsequent monitoring events.

As reminders, Safety Kleen:

- Must continue to notify the Department of field activities in accordance with Specific Condition Part VI Subpart B.3 of your permit;
- Should maintain the remediation system in the event that additional active remediation is needed;

> Should contact me as soon as practicable if any applicable contaminants exceed any of the GCTLs. An e-mail or phone call will be acceptable.

As we discussed on February 7, if the results Site Rehabilitation Completion Report (SRCR) supports completion of remediation, our intent is to public notice the No Further Action through the permit renewal process later this calendar year.
