SPECIFIC COMMENTS: Application Form for a Used Oil Processing Facility Permit and a Waste Processing Facility Permit.

- 1. Florida DEP Application, Form # 62-710.901(6), B.1- Site Information, and Page 9: The facility latitude and longitude should be identified with the appropriate degrees, minutes, and seconds symbols. Please review and update the entry.
- Florida DEP Application, Form # 62-710.901(6), C.3 through C.10, Operating Information, Page 10: Please identify the Attachments on this form. Also, provide copies of all the Attachments with current updates.
- 3. Florida DEP Application, Form # 62-701.900(4), Part B. Additional Information, Page 3 of 4: Please provide the information required in this form including but not limited to, a description of the types of solid wastes received at the facility, a process description for all solid waste activities performed at the site, the identification and capacity of on-site storage areas for recyclable materials, non-processable wastes, unauthorized wastes, and residues as well as the anticipated storage times prior to disposal or reuse, and spotter training requirements proposed upon acceptance of solid waste materials in order to identify and segregate prohibited or unauthorized solid wastes with a description of the management and disposal of any prohibited or unauthorized wastes. In general the Plan does not address solid waste. Please review and address as appropriate.
- 4. Solid Waste Processing / Bulking at the CBI-Port Everglades Facility, Items 1 through 5: Please describe these items in detail specifically for this site. Also, item 6 the units should be "cubic yards" instead of "yards".
- 5. Waste Analysis Plan: The Plan indicates that if a load doesn't meet the established waste profile or the received load is rejected that the records of analysis will be kept on site for at least one year. DEP recommends that per 40 CFR Part 279.57(2) you keep records at least three (3) years instead one (1) year. Please review and revise the documents as appropriate.

- 1. Facility must submit a site map in pdf format (eight and a half by eleven inches), so that this map can be inserted into the permit.
- **2.** Facility must submit a used oil tank table in pdf format (eight and a half by eleven inches), so that this can be inserted into the permit.
- **3.** CBI, Inc. Permit Application Cover Letter dated February 20, 2012 indicates that there have been no changes at the CBI-Port Everglades facility concerning the Used Oil Processing facility permit since the final permit was issued on May 6, 2008. Since the permit was issued about five (5) years ago, and since CBI, Inc. is expanding the site to include solid waste activities on site, the SPCC Plan, Contingency Plan, Emergency Response Contact Information including Phone Numbers, The Training, and Evacuation Routes should be updated to incorporate all relevant changes.
- 4. The Facility Closure Cost Estimates: The facility proposed to expand the site to process solid waste activities. Therefore, the facility must revise the closure costs to include disposal of solid waste quantities. The permit application cannot be considered complete and a permit issued until such time as the revised financial assurance has been provided and approved. Please review the current estimate and revise as appropriate.
