#### Introduction:

On May 23, 2012, John White and Michael Eckoff, Florida Department of Environmental Protection (FDEP), inspected Lamp Sales Unlimited for compliance with state and federal hazardous waste regulations. Lamp Sales Unlimited, located at 1271 LaQuinta Drive, Unit #13, Orlando, Florida, is a supplier of lamps. The facility has been at this location for three and a half years, has four employees, and operates Monday through Friday 7:30 AM to 5:00 PM. The facility was represented by Josh Johnson, Branch Manager.

Lamp Sales Unlimited notified the Department as a transfer facility for universal waste lamps and as a small quantity handler of universal waste lamps and devices and received EPA identification number FLR000142281 on March 19, 2009.

The property is owned by La Quinta Business Center/Mini, P.O. Box 481, Gotha, Florida 34734-0481.

## **Process Description:**

The facility is a supplier of lamps and ballasts. The facility delivers new bulbs to customers and picks up used bulbs at that time. The facility does not accept broken lamps from customers.

Lighting Resources-Ocala picks up used mercury lamps and used ballasts from the facility. The facility stores, at most, four pallets of used mercury bulbs and used ballasts.

Used mercury lamps were stored in boxes on the loading dock. Two boxes were open, Mr. Johnson stated that he opens the boxes to check the contents and re-boxes the used bulbs for shipment.
