Introduction:

The Veolia Transfer Yard (Veolia) is used for the storage of facility transport trailers and is a registered Universal Waste Transfer Area.

Three trailers were randomly inspected to ensure compliance with state and federal regulations. One trailer was empty, a second trailer was full of empty containers, and the third had e-waste stored on it. The storage times vary depending on the content of the trailers. Trailers that have universal waste stored on them are kept in the transfer yard for a maximum of ten days. On the tenth day or previous to that day, the universal waste is off-loaded at the main facility's docking area for processing.

No violations were observed during the inspection of the transfer yard. The Veolia transfer yard appeared to be in compliance at the conclusion of the inspection.
