Introduction:

The facility is a seaport shipping and transfer facility. It has been in operation for over 20 years. It is located on 28 acres, employs about 150 people, and uses city utilities.

Facility was last inspected by the Department on 05/20/2010.

Process Description:

Facility performs maintenance on their own vehicles and generates the following waste streams:

- used oil stored in AST; indoors; within secondary containment; managed by Cliff Berry
- used oil filters and solids stored in four (4) 55-gal drums; indoors; managed by Cliff Berry
- spent antifreeze - stored in AST, indoors; within secondary containment; managed by Cliff Berry
- parts washer mineral spirits wastes 2 System One parts washers; managed by Safety Kleen

There are 2 underground fuel tanks holding gasoline and diesel.

There is an underground 3-unit water-oil separator. Each unit is about 2000 gal, all are maintained by Cliff Berry and waste is picked up on annual basis.

Transfer Facility:

Facility does not take wastes off/out of containers. They accept shipping containers, move them into the parking area and ship them off all without unloading.

The facility recently expanded their facility by adding one lot south of main building. Transfer operations were moved to the newly acquired lot without notification of changes to the Department. No hazardous waste containers were stored in designated transfer area at time of inspection.
