## Attachment A

- Section 5 Procedures Solidification Procedures
  - Item #6 This Item or another appropriate part of Attachment A or attachment to the application should include a description of how the records are kept of which incoming waste containers/loads are included in each solidification batch.
  - Item #8 This item should describe if/how the wash water is collected and disposed.
  - Item #11 Please provide MSDS for the "oil dry" and "Swell-jell" and verify that only physical solidification (not-chemical) results from the use of these products.
  - The Solidification Procedures section should be revised to include a description of the following procedures:
    - procedures for mixing waste and solidification media in solidification tub
    - procedures for removal and loading of solidified waste into outbound containers
- Attachment A should include a description of routine cleaning procedure for the solidification tub and concrete solidification area
- Attachment A or Attachment H Contingency Plan should include a description of the facility's "Response to Releases" from the solidification operation.
- Attachment B No comments at this time
- Attachment C No comments at this time other those provided for Attachment G associated with Attachment C
- Attachment G
  - Attachment G should include the "Closure Methods" for the solidification area, including the solidification tub.
  - Section 9.3
    - The maximum waste inventory should include waste in the solidification area (i.e. a full solidification tub) and the maximum quantity of solidification material (sawdust, oil-dry, etc.) that will be stored at the facility. Figure 9.1 and the facility's closure cost estimate & and proof of financial assurance for closure (Attachment I) should be revised accordingly. Section I-C-1.1.1 of Attachment C may also need to be revised.
