
Dear Mr. Bryant:

FINAL JUDGMENT

The Court, having considered Plaintiff's Motion for Entry of Final Judgment After Default and being otherwise duly informed, the Court finds and it is hereby

ORDERED AND ADJUDGED

1. Within 30 days effective date of this Judgment, Defendant Carl A. Bryant, Sr. must pay the Plaintiff, the State of Florida, Department of Environmental Protection ("Department") the sum of \$16,580.00 in civil penalties and costs under Sections 403.141(1), 403.161(2), and 403.727(4)(d), Florida Statutes, for which let execution issue. Payment must be made by cashier's check or money order and sent to: Department of Environmental Protection, 400 North Congress Ave, Suite 200, West Palm Beach, FL 33401. The check must be made out to: "Department of Environmental Protection, Ecosystem Management and Restoration Trust Fund", with the notation OGC No. 12-1124.

2. Defendant Carl A. Bryant, Sr. is forever prohibited from transporting hazardous waste in the State of Florida under Sections 403.131 and 403.727(2), Florida Statutes.
3. It is further ordered and adjudged that the Defendant shall complete under oath Florida rule of civil Procedure Form 1.977 (Fact Information Sheet), including all required attachments, and serve it on the Department's Office of General Counsel, within 45 days from the date of the final judgment, unless the final judgment is satisfied or post-judgment discovery is stayed. Failure to complete Form 1.977 as ordered may be considered contempt of court. The Defendant is required to file a notice of compliance with the clerk of court and serve a copy of the notice on the Department.
3. The court shall retain jurisdiction to enforce the provisions of this Final Judgment.
