## Dear Mr. Curtis:

As pointed out in the report, 3+4-methylphenol was detected and confirmed above its GCTL in monitoring well MW-4 for the first time. Depending upon the January 2013 results, you may need to assess potential contamination to the northwest of MW-4. Details of the assessment (e.g., specific well(s) and location(s)), if needed, can be determined after your January 2013 results have been received. Keep in mind that if RMOII is pursued, you will need to demonstrate that the plume is stable or decreasing, located on site, and ½ acre or less in size.

As a reminder, the annual review discussed in your NAM Plan<sup>1</sup> must also be submitted with your January 03, 2013 sampling report.
