Dear Mr. McQuillan:

The purpose of this letter is to provide notice that the permit numbered 26916-HO-007 will expire on November 6, 2013. Prior to one hundred-eighty (180) calendar days before the expiration of this permit, a complete application for the renewal of the permit shall be submitted on forms and in a manner prescribed by the Department and as stated in your permit. A complete application is due by May 10, 2013.

One hard and one electronic copy of the permit application shall be submitted. The application shall meet the fee requirements of Rule 62-730.293, Florida Administrative Code. The Permittee shall submit a copy of the cover letter accompanying the permit application, the fee, and the copies of the permit application to:

The renewal fee may also be submitted electronically. However, if the Permittee intends to submit the renewal fee electronically, the Permittee shall obtain instructions from the Department on how to submit the renewal fee prior to attempting such submittal, and shall follow such instructions in making the electronic fee submittal.

On September 15, 2011, a teleconference was held with your staff to discuss updating your Part B during your permit transfer. At that time, we discussed whether to update the entire Part B then or during the renewal of your permit. Let this be a reminder that the entire Part B will need

to be submitted with all text and figures updating references of Perma-Fix to Triumvirate. As the permit application is due on May 10, 2013, feel free to make arrangements for a pre-application meeting as soon as possible if it will assist you.
