Good Morning Ms. Perez,

I spoke with George this morning in our office regarding Spent Fluorescent Lamp Transportation. During a recent inspection of the USCG Key West, it was noted that EMC Oil Corporation was transporting Mercury Containing Lamps. I checked the Department's list of registered mercury transporters and did not find EMC Oil Corp. or Environmental Management Conservation Oil Corporation (EMC) on that list. A review of the attached 8700-12FL Florida Notification of Regulated Waste Activities also does not show EMC listed as a Transporter.

In an effort to assist EMC with complying with the regulations of Florida Administrative Code 62-737, I spoke with George about some of the requirements and provided him with the attached Lamp Fact Sheet (Managing Spent Fluorescent and High Intensity Discharge (HID) Lamps.)

George mentioned that EMC takes the collected spent mercury lamps directly to TRIUMVIRATE ENVIRONMENTAL FLORIDA INC and does not store them at your location (FLR000000166). Therefore, EMC would not to be concerned with the portion of 8700-12FL regarding Mercury-containing lamps (LQH or SQH) for-hire handler (page 3 section 9 B boxes 5 or 6. However, as a transporter, you do need to list that you are transporting mercury containing lamps. On the attached 8700-12FL, page 3 under section 9 B (1) e, you should check the box under Transport. George tells me that you do not handle mercury containing devices. If you find that any other

portions of the mercury containing lamps / devices apply, you should also fill that in. There is no fee associated with the transportation notification / registration and the notification (registration) must be done yearly between January and March.

Submittal of the updated form will place you on our registered mercury transporter list for the services you provided and will provide visibility to potential customers that may be looking for such transporters. Your updated registration should place you on this year's list.

We request that you update your 8700-12FL within 15 days of receipt of this e-mail. As a courtesy, we also request that you acknowledge receipt of this e-mail by sending us a reply to that effect.
