

Dear Mr. Curtis:

Your February 6, 2012 Septic System Plan/Report indicated that Safety Kleen's longterm solution was to connect to the sewer system. Your estimated date of completion was originally May 2012, one year ago. Periodically, you have informed the Department of delays or status, the latest being in your e-mail dated May 10, 2013.

Our February 17, 2012 approval of the Plan/Report instructed you to notify the Department (Tampa and Tallahassee offices) once your connection to the sewer system was completed. To date, you have not completed your proposed corrective actions for this SWMU. Your current report indicates that well MW-2 continues to have the highest groundwater head:

Groundwater flow is out of equilibrium because wastewater continues to enter the septic tank/drainfield area.

Your May 10, 2013 e-mail indicates that you expect all legal issues be resolved and necessary permits in place before the end of this month and that contractors will begin work immediately upon receipt of the permit. As is, the potential still exists for discharges of contaminants to the septic tank/drainfield area.

We agree that according to paragraph 62-780.690(8)(g), Florida Administrative code, that a minimum of two consecutive clean sampling events are required for consideration of the NFA. However, these events will begin once the sewer connection has been completed and groundwater reaches equilibrium. Your next groundwater sampling must be performed in July 2013.
