Dear Mr. Moore,

I have received your letter of September 20, 2013, enclosing a notification of intent to import hazardous waste from the Bermuda Hospital Boards for shipments to Veolia ES Technical Solutions, LLC, Port Arthur, Texas. Bermuda and the Government of the United States do not have an agreement providing for prior notice and consent to control imports of hazardous waste. Furthermore, there is no restriction in US law on the entry of hazardous waste from Bermuda into the US. Accordingly, the United States Environmental Protection Agency does not have any basis for responding to this import notice, and the hazardous waste may freely enter the United States, subject to all applicable domestic hazardous waste or other legal requirements.
