Per our telephone conversation this morning I have two comments:

- 1. Page 15 of 38, Part II Subpart A, 5. a.: The Permittee is liable for waste profiles supplied to generators. The Department had previously agreed to remove this language from SK permits.
- 2. Page 17 of 38, 12. b.: copies of the CP must be submitted to the authorities/facilities in Condition II.A.11.c-Authorities/facilities include local fire and police departments, sheriff's office, state police, hospitals, ambulance services and emergency medical technicians, and state and local emergency response centers. We would suggest listing authorities/facilities that are listed in the Part B such as the Clay County Sheriff, Clay County Fire Rescue, Orange Park Medical Center to make it more specific regarding who we are required to submit the plan to.
