The Florida Department of Environmental Protection gives notice that it has determined to issue an Operating Permit to Triumvirate Environmental Inc. The Permit authorizes Triumvirate Environmental (Florida) Inc. to operate a hazardous waste container storage and treatment facility at the Triumvirate Environmental (Florida) Inc., site in Orlando, Florida.

Any person who opposes the Department's action may file a petition for an administrative hearing or request a public meeting. Any request must be received by the Department within 45 days of this announcement.
