2. Person Filing Report: Russ Giambrone

3. Date and Time of Incident: August 6, 1992 at 1:30 P.M.

4. Description of Incident: The Safety-Kleen truck was proceeding through intersection, was struck, and then overturned. The lids on seven containers leaked solvent onto the pavement.

5. Extent of Personal Injuries: Three people were taken to the hospital and released.

- 6. Extent of Property Damage: Both car and Safety-Kleen truck appear to be totally destroyed.
- 7. Description and Estimated Quantity of Material Released: Approximately 70 gallons spilled of mineral spirits.
- 8. Human Health and Environmental Impact: None
- 9. Remedial Action Taken: The Brunswick Fire Department placed sand around the truck to prevent run-off, and foamed the area to prevent potential fires. The material used in containing and cleaning up the spill was drummed and moved to the Safety-Kleen facility noted in this report. Approximately 1-2 gallons leaked into the storm sewer. The sewer was flushed for 1/2 hour by the Fire Department.
- 10. Estimated Quantity of Clean-Up Reside for Treatment and Disposal: A total of 8-85 gallon drums of contaminated dirt and absorbent wipes were generated. Drum will be shipped to a Safety-Kleen Recycle Center for disposal.

This letter also serves as notification that the spill has been cleaned up, and that all emergency equipment is again ready for use. Please contact me at 904-264-2607 if you have any questions.
