
Dear Mr. Patel:

E. Method of treatment, Strong, and Disposal:


The Wastes in section D were stored at the Orange Park facility in the RCRA permitted storage tank. They were then shipped via Safety-Kleen tank truck and Safety-Kleen's Recycle Center in Lexington, South Carolina, and then recycled back into clean mineral spirits by distillation for reuse by Safety-Kleen customers.

F. Explanation of Why Waste Was Unmanifested:

The wastes referenced in Section D above were transported from this customer without manifests. Enclosed with this appendix are the Safety-Kleen transportation documents (also known as preprints) in question. The Orange Park facility which transported and received the wastes was not aware at those times that the customer was a Large Quantity Generator. Florida Wire and Cable had been certifying on Safety-Kleen preprints that they are Small Quantity Generator. We were notified on Monday, April 12, 1993, that Florida Wire and Cable was a Large Quantity Generator as of December, 1992.
