A person whose substantial interests are or will be affected by the Internt to Issue may petition for an administrative determination (hearing) under Sections may petition for an administrative determination (hearing) under Sections 120.569 and 120.57, F.S. The petition must contain the information set forth below and must be filed (received) in FDEP's Office of General Counsel, Agency Clerk, 3900 Commonwealth Soufevard, Mail Station #35, Talfahasse, Florida 32393-3000. Petitions filed by the Florica 32:393-3000. Petitions filed by the permit applicant and any parties entitled to written notice under Section 120.60(3), E.S. must be filed within 45 days of receipt of the Intent. Petitions filed by any other persons must be filed within 45 days of publication of this notice or receipt of the Intent, whichever occurs first. A petitioner shall mail a coru of the petition of the section of the Intent, whichever occurs first. A petitioner shall mail a copy of the petition to the applicant at the address inclicated above at the time of filing. The failure of any person to file a petition within this time period shall constitute a waiver of that person's right to request a hearing under Sections 120.559 and 120.57, F.S. Any subsequent intervention (in a proceeding tritiated by another party) will be only at the discretion of the presiding officer upon the filing of a motion in compliance with Rule 28-105.205, F.A.C.

A petition that disputes the material facts on which FDEP's action is based must contain the following information:

(a) The name, address, and telephone number of each petitioner, the applicant's name and address, the PDEP Permit File Number and the county in which the pro-ject is proposed; (b) A statement of how and when each petitioner received notice of FDEP's action or proposed action; (c) A statement of how each petitioner's sub-stantial interests are affected by FDEP's proposed action; (if) A statement of all material facts disputed by petitioner, or a statement that there are no disputed facts; (e) A statement of facts which petilioner contends warrant reversel or modification of FDEP's proposed action; (f) A statement of which rules or statutes the satisment of which these or statutes his potitioner contends require reversal or modification of FDEP's proposed action; and (g) A statement of the relief sought by potitioner, stating precisely the action petitioner wants the Department to take with respect to the proposed action.

A petition that does not dispute the material facts on which FDEP's action is based shall state that no such facts are in dis-pute and otherwise shall contain the same information as set forth above, as required by Rule 28-106.301, F.A.C.

Because the administrative hearing process is designed to formulate final agency action, the filing of a polition means that FDEP's final action may be different from the position taken by it in this notice.
