THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (FDEP) GIVES NOTICE OF ITS INTENT TO ISSUE A PERMIT UNDER SECTION 403.722 and 403.707, FLORIDA STATUTES (F.S) AND CHAPTERS 62-4, 62-701 AND 62-730, OF THE FLORIDA ADMINISTRATIVE CODE (F.A.C) TO EQ FLORIDA, INC. with respect to the facility at 2002 North Orient Road and 7202 East 8th Avenue in Tampa, Hillsborough County, Florida, having assigned EPA Hazardous Waste Facility I.D. number FLD 981 932 494 and Solid Waste ID# 44633.

The draft permit contains modifications to operate a hazardous waste storage facility, to construct and operate a hazardous waste treatment tank, to operate a solid waste materials processing facility, to operate a hazardous waste transfer facility and to implement facility-wide corrective action at the existing EQ Florida Inc. Hazardous and Solid Waste Facility located at 2002 North Orient Road and 7202 East 8th Avenue in Tampa, Hillsborough County, Florida.

Section 120.60(3), F.S. must be filed within 45 days of receipt of the Intent. of how each petitioner's substantial interests are affected by FDEP's proposed action; (d) A statement of all material facts disputed by petitioner, or a statement that there are no disputed facts; (e) A statement of facts which petitioner contends warrant reversal or modification of FDEP's proposed action; (f) A statement of which rules or statutes the petitioner contends require reversal or modification of FDEP's proposed action; and (g) A statement of the relief sought by petitioner, stating precisely the action petitioner wants the Department to take with respect to the proposed action.
