# FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION NOTICE OF INTENT TO ISSUE

THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (FDEP) GIVES NOTICE OF ITS INTENT TO ISSUE A PERMIT UNDER SECTION 403.722 and 403.707, FLORIDA STATUES (F.S.) AND CHAPTERS 62-4, 62-701 AND 62-730, OF THE FLORIDA ADMINISTRATIVE CODE (F.A.C.) TO EQ FLORIDA, INC. with respect to the facility at 2002 North Orient Road and 7202 East 8th Avenue in Tampa, Hillsborough County, Florida, having assigned EPA Hazardous Waste Facility I.D. number FLD 981 932 494 and Solid Waste ID# 44633.

The draft permit contains modifications to operate a hazardous waste storage facility, to construct and operate a hazardous waste treatment tank, to operate a solid waste materials processing facility, to operate a hazardous waste transfer facility and to implement facility-wide corrective action at the existing EQ Florida Inc. Hazardous and Solid Waste Facility located at 2002 North Orient Road and 7202 East 8th Avenue in Tampa, Hillsborough County, Florida.

A person whose substantial interests are or will be affected by the Intent to Issue may petition for an administrative determination (hearing) under Sections 120,569 and 120,57, F.5. The petition must contain the information set forth below and must be filed (received) in FDEP's Office of General Counsel, Agency Clerk, 3900 Commonwealth Boulevard, Mail Station #35, Tallahassee, Florida 32399-3000. Petitions filed by the permit applicant and any parties entitled to written notice under Section 120.60(3), F.S. must be filed within 45 days of receipt of the Intent. Petitions filed by any other persons must be filed within 45 days of publication of this notice or receipt of the Intent, whichever occurs first. A petitioner shall mail a copy of the petition to the applicant at the address indicated above at the time of filing. The failure of any person to file a petition within this time period shall constitute a waiver of that person's right to request a hearing under Sections 120.569 and 120.57, F.S. Any subsequent intervention (In a proceeding initiated by another party) will be only at the discretion of the presiding officer upon the filing of a motion in compliance with Rule 28-106.205, F.A.C. A petition that disputes the material facts on which FDEP's action is based must contain the following information:

(a) The name, address, and telephone number of each petitioner, the applicant's name and address, the FDEP Permit File Number and the county in
