Thank you for taking the time today for the call, we really appreciate it.

At this time the Veolia Tallahassee facility is seeking the Departments approval to store the Non Hazardous Aluminum End Caps that are in question on a trailer in the 10 Day HW Transfer area of the facility (the fenced in yard)

If allowed the following would be the guidance used.

1. Trailer would stay on pavement
2. Only aluminum that has been tested would be stored.
3. Each container would be clearly marked
4. A spreadsheet log of the containers will be maintained by the Operations Manager and/or the Operations Supervisor.

Further as a result of the call between the Tallahassee staff (local) and the EH&S Managers we will continue to investigate the cause of the current issue with the results.
