RUOH	03/25/2014	Email sent to Jan Barnes: Pursuant to Rule 62-710.201, Florida Administrative Code, a used oil transporter is any person who transports used oil over public highways, any person who collects used oil from more than one generator and transports the collected oil over public highways, and owners and operators of used oil transfer facilities. Therefore, you are required to register the Ft. Lauderdale and Sanford facilities as UO transporters and show proof of insurance. You may also want to consider registering the Jacksonville and Tampa facilities as UO transporters to ensure they can transport used oil. Attached for your convenience is a copy of the Used Oil Rule, a blank copy of the 8700 Notification form, and Combined HWT/UO Certificate of Liability Insurance form. Please submit the following to continue processing your renewal registrations: Revised Page 4 of the 8700 form for all facilities and Combined HWT/UO Certificate of Liability Insurance form for Ft.
