The Florida Department of Environmental Protection (the Department) has reviewed your permit minor modification application dated February 19, 2015 and received on February 26, 2015 to operate a Used Oil and Material Processing Facility in Jacksonville, Florida.

The review of the permit application indicates that it is incomplete. Please provide the information requested as shown below:

- 1. The Facility needs to submit the Solid Waste Permit Application Form 62-701.900(4), F.A.C. as appropriate.
- 2. The Facility needs to update all Site Maps in an electronic format (pdf preferred), size- 8<sup>1</sup>/<sub>2</sub>"×11", so that these maps can be inserted into the permit.
- 3. The Facility needs to update Tank Table in an electronic format (pdf preferred), size- 8<sup>1</sup>/<sub>2</sub>"×11", so that the tank table can be inserted into the permit.
- 4. Permit Application in electronic version (DVD/CD), so that the application can be easily inserted into OCULUS.

In preparing your response, the Department recommends that you identify each comment followed by your response and also provide your revised pages of the application. The revised pages are to include the new revision date.

The Department will be contacting you to schedule a meeting or conference call to discuss these comments. Additional communications will be scheduled as needed prior to your submittal of an official response to minimize the time and effort required to formulate adequate replies to the comments. This

exchange of ideas will assist you in developing a complete and adequate response that should eliminate the need for additional official responses and therefore accelerate the permit modification process.

Further action on processing your application is temporarily held in abeyance pending receipt of your complete response. Please submit your written response and electronic copy to the Tallahassee Hazardous Waste Program and Permitting. If you cannot submit all this information within 30 days, you must formally request an extension and provide a schedule, with dates, indicating when this information will be submitted.
