The Florida Department of Environmental Protection (the Department) has reviewed your permit application, NOD responses dated March 27, 2015 and received on March 31, 2015 to operate a Used Oil Processing Facilities in Florida.

The review of the permit application responses indicate that they are incomplete. Under Paragraph 62-710.800(6)(a), Florida Administrative Code, the "Owner or Operator of a used oil processing facility shall provide the Department with proof of financial assurance issued in favor of the State of Florida in the amount of the approved closing cost estimate for the facilities, which shall be submitted to the Department as part of the permit application process".

Please provide the Financial Assurance Final Documents information requested through an e-mail dated April 13, 2015 by Susan Eldredge, Solid Waste Financial Coordinator, in DEP, Tallahassee, Florida. The Department will be contacting you to schedule a meeting or conference call to discuss these comments. Additional communications will be scheduled as needed prior to your submittal of an official response to minimize the time and effort required to formulate adequate replies to the comments. This exchange of ideas will assist you in developing a complete and adequate response that should eliminate the need for additional official responses and therefore accelerate the permit transfer process.
