Introduction:

Quality Carriers Inc., was inspected on August 13, 2015, to determine the facility's compliance with state and federal hazardous waste regulations. This transporter was previously inspected by the Department on August 7, 2000, June 3, 2005, May 25, 2007, March 17, 2010, and February 1, 2012. Mr. Mark Sorine (Vice President of Safety & Security) and Ms. Cynthia Harvey (Director of Safety) assisted the Department representatives in obtaining the required transporter records. Additional assistance was provided via telephone by Jim Rakitsky (Vice President of Environmental Services).

Process Description:

Quality Carriers is a transporter of bulk materials for large customers. Primarily they transport bulk products although they also transport hazardous waste under their Florida EPA ID number. According to facility personnel, no hazardous waste or bulk products are ever brought to this location. At the time of the inspection, no trucks were available for inspection at this location.

Quality Carriers has more than 100 terminals throughout the United States and Canada. This location is the corporate headquarters for Quality Carriers. Hazardous waste manifests are kept at each individual terminal throughout the country. Bulk shipments are picked up from their clients and then transported directly to treatment, storage and disposal (TSDF) facilities. Typically they do not pickup drums from their clients, and they do not provide services to conditionally exempt small quantity generators (CESQG) and/or small quantity generators (SQG).

As no hazardous waste manifests are kept at the Tampa office location, the inspector requested copies of a random sampling of manifests from March 2012 through July 2015. The manifests reviewed were from multiple generators: PPG Industries in Delaware, OH; Vencorex US in Freeport, TX; Cherokee Pharmaceuticals in Riverside, PA; DuPont Performance Coatings in Fort Madison, IA; Axalta Coating Systems in Fort Madison, IA; ISP Chemicals in Calvert City, KY; Safety-Kleen Canada

in Nisky, Alberta Canada; Air Products & Chemicals in Calvert City, KY; and Arkema North Kansas City in North Kansas City, MO. No violations of the transporter requirements for hazardous waste were noted. According to Mr. Sorine, there have been no hazardous waste or used oil shipments in or out of Florida from July 2013 through June 2015.

The company employs approximately 2,400 drivers. DOT training records were reviewed for 24 drivers. All hazardous materials training certificates and fit test records for each driver was readily available and current. The company's annual SOP review for screening wastes prior to acceptance for transport was last reviewed in March 2014. According to Ms. Harvey the SOP was in the process of being revised for 2015.

The facility's Emergency & Oil Spill Response Plan dated March 2014, was reviewed. The plan appeared to be adequate. Currently they utilize Skytank as their spill reporting contractor (1-800-SKYTANK).

Quality Carriers maintains adequate financial responsibility through Zurich American Insurance Company, and records were available at the facility.

Conclusion:

At the time of the inspection, Quality Carriers Inc., was operating in compliance with state and federal hazardous waste regulations governing transporters.
