Hi Roger,

Moving forward Safety-Kleen will use the same procedures we currently employee to ensure we are not accepting used oil mixed with fuels. They are:

For industrial customers, Safety-Kleen takes a sample of the material before acceptance into its' used oil program (SKOS), which is tested for flash point, PCB's, Halogens, Silicone, and VOC's. In addition, all SKOS customers (Industrial/Automotive) have a representative retain sample taken at each service stop BEFORE the used oil is pumped onto the collection truck – this retain sample is held at the branch for a time period in case needed in a contamination event. At that point the driver(s) are able to check the material for appearance (used oil mixed with fuels may cause the material to have a thinner/lighter appearance), unusual odors, and viscosity (used oil mixed with fuels would have a noticeably lower viscosity and flow more easily into the sample jar). Any indication of the above factors would result in the driver communicating to the generator that the material has to undergo pre-qualification testing before acceptance into our oil program.
