According to Rule 62-710.600, Florida Administrative Code, used oil transporters are required to maintain vehicle insurance at all times when transporting used oil. Handling used oil or used oil filters without liability ASHWOOD_J insurance and a valid registration is a violation of the law, subject to penalty.
