Glen,

I have performed a Case Specific Classification Review for Ring Power Corp, EPA ID # FLD982150237. The inspector cited four violations in the report:

261.5(g)(3) CESQG improper treatment or disposal of hazardous waste (not acutely toxic) This violation was cited because the facility was not collecting a very small amount of waste generated from puncturing aerosol cans.

This violation was **Minor X Minor**

279.22(c)(1) Containers and aboveground tanks used to store used oil at generator...facilities must be labeled or marked clearly with the words Used Oil. This violation was cited because one 5-gallon bucket was not labelled. This was only one of many buckets. **Minor X Minor**

62-710.401(6) No person may store used oil in above-ground containers unless such containers are clearly labelled.......they must be stored on an oil-impermeable surface such as sealed concrete or asphalt, and must have secondary containment. This violation was cited because three drums (out of many more) were stored on the edge of the secondary containment berm and not inside the containment berm. **Minor X Minor**

62-710.500(4) Each registered person shall display the validated registration in a prominent place at each facility location. This was cited because the current registration, though available, was not posted. **Minor X Minor** (Guide Number 26 and 27)

Three of these violations were repeat violations from the last inspection dated 12/16/2010. I find that although these violations are repeated they are all minor X minor on the Guidelines for Characterizing Used Oil Violations. Therefore, I agree with the district that a formal enforcement response is not necessary in this case. I suggest adding a sentence in the narrative/comments/wrap-up of the inspection report that there are some repeat violations.
