Enclosed are un-manifested waste reports for the above listed generators. During preparation of the 2015 biennial report it was discovered that the Safety-Kleen Orange Park facility picked up hazardous waste parts washer solvent that exceeded the CESQG limit from these generators on several occasions in 2015. These transactions were completed on hand-held shipping documents, which contain the proper waste description and waste code. Copies are attached for your review.

All waste was handled according to standard hazardous waste management procedures. At no time did the waste pose a threat to human health or the environment.


