Jeff,

I have an update (attached). It looks like when the permit was issued for your May 2001 Application, SWMU-11 was placed on the NFA Table. So, it looks like a decision was made sometime between May 2001 and March 2002 that moved SWMU-11 from awaiting EPA comments to an NFA. This narrows the timeframe for looking for any missing documentation on SWMU-11. If you cannot find any additional documentation, I'll reference the permit as the document memorializing the NFA.

BTW, I now seem to recall this issue coming up when we first started working on SWMU-21 (septic tank) because SWMU-21 was located on top of an existing SWMU. I'll see if I have any notes from that time.

Having said that, I need your help on SWMU-11 Old Dumping Grounds. Attached is the last documentation I can find in OCULUS. Admittedly, OCULUS does not have every document in it that should be there.

According to SK's May 2001 renewal (attached) EPA had not yet commented on the RFI Workplan ECT had submitted in September 1994! What I am looking for is an EPA (or maybe DEP) letter moving SWMU-11 to an NFA. Any chance you can check through your operating records and see if you can find out what happened? If you have the document(s), I'd like electronic copies so that I can enter them into OCULUS. No *immediate* rush because but I'd like to clean that up and get the documentation into the permit this time. However, I hope we can have a draft permit to you next month to review.
