Introduction:

On December 7, 2016, Michael Eckoff, Florida Department of Environmental Protection, accompanied by Eric Kramer, CB&I, inspected CB&I Environmental and Infrastructure, Inc. for compliance with state and federal hazardous waste transporter requirements. The facility most recently notified the Department of its waste activities on August 22, 2016 and was originally issued EPA ID FLD980799381 on July 9, 2002 under the name of Shaw Environmental, Inc. and located at 415 Citrus Tower Boulevard, Clermont, Florida 34711-6535. Shaw Environmental, Inc. moved from its Clermont location to its current location sometime between 2009 and 2010 and also changed its name to CB&I Environmental and Infrastructure, Inc. sometime in early 2014.

The facility's current hazardous waste transporter registration expires on November 30, 2017.

INSPECTION HISTORY

The facility has not been inspected by the Department within the past five years for compliance with state and federal hazardous waste transporter requirements.

Process Description:

The facility consists of office space and a warehouse.

Mr. Kramer stated transportation of hazardous waste is sub contracted to another registered hazardous waste transporter. He also stated that transportation of hazardous waste by CB&I Environmental and Infrastructure, Inc. has not occurred in over three years.

The warehouse contained supplies and equipment. No hazardous waste appeared to be stored in the warehouse. Two trailers were stored outside the warehouse that Mr. Kramer stated contained clean up/remediation supplies and equipment.

CB&I Environmental and Infrastructure, Inc. was inspected as a hazardous waste transporter and no potential violations were noted at that time.


