On Page 3, #C(2), Renewal should not be checked because this facility is not permitted as a mercury recovery or reclamation facility. 3. On Page 5, the Certification in #17 must be signed and dated by the owner, operator, or authorized representative of the facility. In addition, type or print the name and corporate or job title.
