Dear Mr. Kothur:

Lighting Resources, LLC is submitting this Application to renew the permit for the Ocala facility. The facility layout and operations remain the same as the last Modification submitted in 2013. A check for \$2,000 is enclosed for the renewal fee.

The Renewal has been prepared to meet applicable federal and state regulatory requirements including but not limited to Rules contained within Chapter 62-737 F.A.C. (The Management of Spent Mercury-Containing Lamps and Devices Destined for Recycling.) Further, the Application has been prepared in accordance with the instructions contained in DEP Form No. 62-737.900.

Two separate documents have been modified for this Renewal:

A. The Application includes title and phone number changes, as well as, updated expiration dates on permits. The total amount of pallets located within the facility has not changed. However, an E-waste category has been added for the storage area for material awaiting processing, sorting and transfer

B. The Engineering Report pages 2, 19, 27 and 48 were changed

Page 2 1.3 relates to changes in E-waste.

The facility has continued to accept E-waste, however this category has expanded to include Non-RCRA Material defined as laptop computers, computer processing units, keyboards, hard drives, motherboards, and retail E-waste. Retail e-waste includes all retail and wholesale items that are battery operated or have an electric cord. This requires that in the sorting and accumulation process the batteries and cords are removed prior to transfer to another facility for shredding or disposal. The process takes place in the staging areas of the facility. This material is stored in space available in rows 1 through 10. The Closure Cost for pallets of lamps replaced by E-waste is nearly equal. Therefore, the current closure amounts are sufficient for any E-waste pallets.

Page 2, 1.4 relates to expiration dates of facility permits.

Page 19, 3.0 again relates to change in E-waste received at the facility.

Page 27 3.12 Again relates to change in E-waste received at the facility.

Page 48 Updated the Emergency Contact Information and removed home addresses.

Attached is a copy of the revised Application and the 4 pages updated from the Engineering Report. The FedEx will have a completed Application and Engineering report along with a flash drive.
